



Truck Loading Policy and Indemnification/Waiver

Loading Over 80,000 Gross Vehicle Weight

From time to time drivers request that a facility owned or operated by CF Industries Sales, LLC or its affiliates ("CF") load trucks in excess of the federally established 80,000 lbs. gross weight limit. Certain states allow a truck's gross weight on state highways to exceed 80,000 lbs. provided the driver (i) has an appropriately configured tractor-trailer combination and (ii) is appropriately licensed and permitted with the state authorities. At the request of a driver CF will load a truck to its maximum permitted weight subject to the below loading policy. The truck driver carrying the load is at all times responsible for observing the established load limits.

1. No CF facility will load product into any motor vehicle in excess of the federally established 80,000 lbs. gross weight limit except in accordance with the following requirements:

1. The carrier has delivered to CF a signed copy of this Truck Loading Policy and Indemnification/Waiver;
2. The driver has requested loading in excess of 80,000 lbs. and has delivered to CF a signed copy of the attached **Driver Indemnification and Waiver for Excess Weight**; and
3. The driver has produced a valid state permit (and other documentation if required) indicating that the tractor-trailer combination is legally capable of transporting more than the federally allowed gross weight and that allows the requested excess load for the requested vehicle.

2. CF is not responsible for ascertaining the validity of a driver's excess loading permit nor is CF responsible for verifying a truck's axle configuration. If, however, CF personnel have a reasonable suspicion that a driver or tractor-trailer combination does not meet the excess load requirements, CF will not load the truck beyond the 80,000 lbs. load limit.

To allow CF to comply with a driver's request for loading a vehicle in excess of the federally established 80,000 lbs. gross weight limit, please sign and return this Truck Loading Policy and Indemnification/Waiver.

CF personnel will also ask any of your drivers that request to load over 80,000 lbs. gross vehicle weight to sign the attached **Driver Indemnification and Waiver for Excess Weight**. The driver will also need to present a valid cab card indicating the driver and vehicle are permitted for the requested load.



INDEMNIFICATION/WAIVER

The undersigned carrier acknowledges (i) that it is licensed and fully-authorized, and that those vehicles which are used for such purpose are licensed and fully-equipped, to transport product in excess of the federally established 80,000 lbs. gross weight limit and (ii) that its drivers are authorized to request loading in excess of the federally established 80,000 lbs. gross weight limit.

The undersigned carrier is familiar and will comply, and will cause its drivers to be familiar and comply, with all federal, state and local loading and transportation laws and restrictions applicable in the states within which product will be transported. The undersigned represents that it possesses the necessary insurance, licenses, tags, registrations and vehicles to legally transport the requested load of product from the facilities of CF Industries Sales, LLC and its affiliates.

THE UNDERSIGNED CARRIER AGREES TO INDEMNIFY, DEFEND AND HOLD HARMLESS CF INDUSTRIES SALES, LLC AND ITS AFFILIATES, AND THEIR RESPECTIVE DIRECTORS, OFFICERS, AGENTS, EMPLOYEES AND CUSTOMERS, FROM AND AGAINST ANY AND ALL LOSS, COST, DAMAGES, FINES, PENALTIES, COSTS OR EXPENSES, OR CLAIMS THEREFOR, ARISING OUT OF OR RELATING TO THE LOADING OF TRACTOR-TRAILER UNITS TO THE WEIGHT REQUESTED BY ITS DRIVERS.

The signature by an authorized officer and return of this document will indicate your approval and acceptance of the above Indemnification/Waiver allowing your drivers to load over 80,000 lbs. gross vehicle weight when in full compliance with all state and federal laws.
